  - Questions targeted at Disaster Awareness,
  - Expectancy,
  - Measures people take to manage,
  - How do they prepare for them in future,

# Survey Data & Sociological Perspectives

## Warning Source that people trust..

Country	TV – Radio Reliance on Media – Technology	Village Committee, Bells, Loudspeaker, Neighbors <b>LOW</b> Reliance on Community System
Sri Lanka	87%	15% (VC/Nbr-9)
Thailand	78%	15% (VC/Nbr-9)
India	70%	25% (VC/Nbr-38%)

**Deceptive security – Need to ensure that community receive it.**

# Action Steps

I do not know who to get right information from.

I am Panicked. I do not feel confident whether I should take time out to help others.

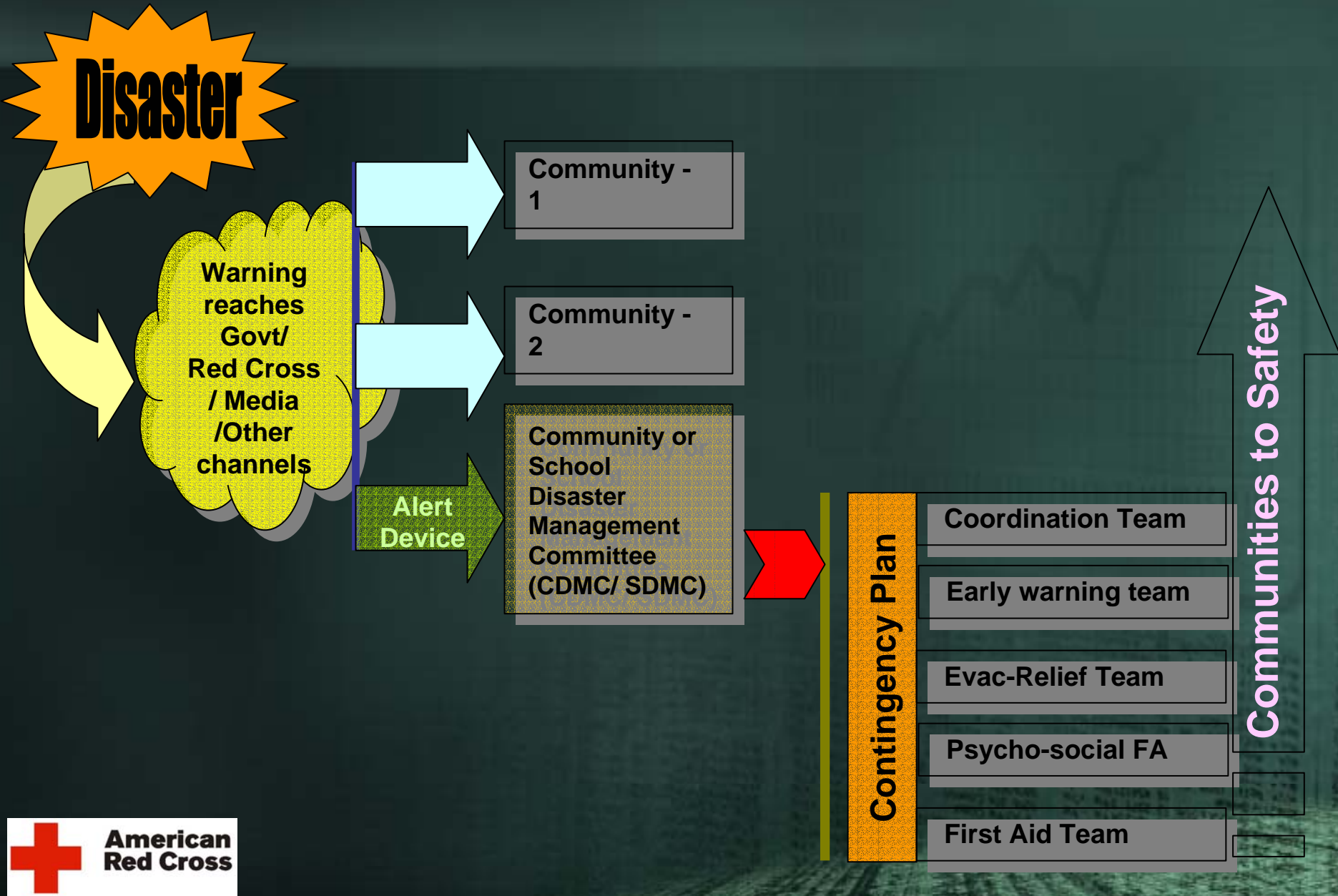

# 1. Survey- Informs DRR Program Design

- **Over Reliance on Media-Technology**
  - System may not work if warning comes at 0300 Hrs or so.
- **Little Family Preparedness Planning**
  - Help plan where they could meet, after a disaster.
- **Little Community plans and drills**
  - Negligible participation, no readiness. How community assist to save EVIs in their planning.
- **Living in the Same Area**
  - How to ensure future disasters impacts are mitigated or prevented?

**C> Definitions & clarifications on numerators/D**

- **HH Level Indicators:**

- "a. % of households in participating communities that can identify disaster warning information source."
- b. % of households in participating communities that can identify a safe meeting place.
- c. % of households in participating communities that have participated in an emergency drill during year.



## 2. Examples of M&E in ARC: contd

Set of Indicators, subscribes to Global AF..

- **Community Level Indicators**

- a. # of participating communities conducting a minimum of one mock disaster exercise/scenario in past year.
- b. % of participating communities successfully conducting a minimum of one mock disaster exercise/scenario in past year.
- c. % of participating communities with updated Contingency plans.

# Issues- Other Indicators for DRR

- Quantifying Risks & Vulnerability.
- Ownership: Who is principle **Process Owner**?
- Quantifying Socio-economic factors.
- Participatory mechanisms & DRR sustainability.
- Complimentarity Issues ie people may NOT have a Community Plan because there is no (State) Early Warning Dissemination System.
- Preparedness can not be seen in isolation from DRR. People have to learn to live with disasters while they are learning to manage it. Combined indicators.
- Climate Change adaptation as a separate stream- At grassroots, it needs to be integrated into DRR.

# Practical Factors

- Impact Evaluation on Mitigation needs time. 10-15Years
  - Standards are required to maintain standards of work which we do, though its impacts may be measured by others.
- DRR against only one hazard means nothing in a multi-hazard prone community. How to cover that aspect?
- DRR a function of Acceptable Risk and will change M&E, with a change in “Acceptable Risk norms”.
- M&E – To be part of Good Governance Practices rather than guest agency’s {temporary} initiative in Indonesia
